SC/ST candidate included in the Short List are required to produce 2 (Two) copies of Community Certificate issued by the Revenue Authority for Producing before the PSC and the candidates belonging to other Backward Classes included in the short list, are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SCSTDD dated 26.09.2009 along with the other documents mentioned above. Such candidates in the Main List who fail to produce the required community Certificate/ Non – Creamy layer Certificate will not be entitled to the benefit of community reservation and will be considered as open competition candidates. The date, time and place of Interview will be intimated in due course.

According to the existing procedure, revaluation of answer script is not allowed. But candidates can apply for rechecking/photocopy of their answer scripts within 45 days from the publication of the Ranked List for the post.
