Note :- (4) Physical Measurement and Physical Efficiency Test will be conducted for the Candidates included in the Short List. Date, time and Venue of Physical Measurement and Physical Efficiency Test will be intimated by SMS and profile message in due course.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes, included in this List, are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/2009/SCSTDD dated 26/09/2009 issued by Village officer and SC/ST candidates, included in the List, are required to produce Community Certificate (Form III or digitally signed) issued by the Revenue authority not below the rank of Tahsildar and candidates who claim EWS reservation are required to produce EWS certificate issued by the Revenue Authority, along with other documents at the time of OTR verification.

Note :- (7) Copy of answer scripts of the OMR Test held on 05-09-2022 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No:ER XVI (I) 4674/22/EW dtd:30/12/2022.
