Note :- (2) The Short List is prepared based on the details furnished by the candidate in the application and subsequent claims will not be entertained at any stage.

Note :- (3) The list has been prepared by including the number of candidates who have secured top marks in the OMR Test.

Note :- (4) **26 (Twenty six)** candidates who have secured top most marks in the OMR examination are included in the Main List of this Short List. The marks secured by the last candidate in the Main List is **45 (Forty five)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other backward Classes, Economically Weaker Section and Differently Abled necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (5) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published shortly.**

Note :- (6) The Register Number of those candidates who do not produce the required documents within the prescribed timelimit and whose application found otherwise defective will be deleted from the Short List without further notice.

Note :- (7) Candidates belonging to Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/SC/ST/DD dated 26.09.2009 and SC/ST candidates are required to produce Community Certificate issued by the Revenue authority at the time of OTR Verification. Differently abled candidates are required to produce Medical Certificate at the time of Certificate Verification. Economically weaker sections are required to produce EWS certificate issued by the concerned authority at the time of OTR verification.

Note :- (8) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (9) Copy of answer scripts of the OMR Test held on **20-06-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER I(2) 3780/2023/EW DATED 20/09/2023.
