For the purpose of satisfying the rules of reservation of appointment to Sheduled castes/Sheduled tribes /Other Back ward classes (and other reserved catagories if any) necessary supplimentary list is prepared by including sufficient number of candidates from lower mark range in the order of merit of the candidates belonging to such classes .

Note :- (4) Candidates included in the Short List should present in person for OT Verification and Interview with all original documents . Date,time and venue will be intimated in due course through profile message and sms .

Note :- (5) According to the existing procedure revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List notes to be published for the post

Note :- (6) SC/ST Candidates included in the Short List are required to produce Community certificate (in Form III digitally signed) issued by the concerned Revenue authority . Candidates belonging to other reservation group should produce Non Creamy layer certificate and those who claimed EWS should produce relevant certificate issued by Village officer at the time of OTR Verification

Note :- (7) Copy of answer scripts of the OMR Test held on **12-06-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Answer scripts of no candidates are invalidated as per Notification No : ERII(2)4009/2023/EW Dated 01/11/2023
