Note :- (2) The list has been prepared by including the number of candidates who have secured top marks in the OMR Test.

Note :- (3) **50 (Fifty)** candidates who have secured top marks in the OMR Test are included in the Main List of this Short List . The Marks secured by the last candidate in the Main List is **51.67 (fifty one(point) six seven)** . For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any), necessary Supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such cases.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published shortly.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to the SC/ST category included in the Short List are required to produce Community Certificate (Form III / Digitally signed) issued by the Revenue authority at the time of OTR Verification.Those belonging to other reservation groups should produce Non creamy layer certificate for state employment purpose as per GO (P)No.81/09/SC/STDD dated 26.09.2009.Those included in the EWS list should produce the relevant EWS certificate issued by the Revenue authorities.

Note :- (7) Copy of answer scripts of the OMR Test held on **12-06-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ERII(2) 4009/2023/EW dated 01/11/2023.
