ORDER

As per Pay Revision Order 2009 read 2nd above, there exists promotion posts of Insurance Medical Officer Gr. I (Homoeo) in the scale of pay of ₹ 21240-37040 and Insurance Medical Officer Gr. II (Ayur) in the scale of pay of ₹ 20740-36140, for the posts of Assistant Insurance Medical Officer (Homoeo) and Assistant Insurance Medical Officer (Ayur) respectively, below the post of Deputy Director in the respective branches of Insurance Medical Services Department. But according to the Special Rules read as 1st paper above, the 1st and 2nd promotion posts of Assistant Insurance Medical Officer (Homoeo) are Insurance Medical Officer Gr. II (Homoeo) and Insurance Medical Officer Gr. I (Homoeo) and those of Assistant Insurance Medical Officer (Ayur) are Insurance Medical Officer Gr. II (Ayur) and Insurance Medical Officer Gr. I (Ayur).

Considering the above and also for maintaining parity in the scales of pay of the posts in the Homoeo and Ayurveda branches of Insurance Medical Services Department with their counter parts in Homoeopathy Department and Indian Systems of Medicine Department, Government are pleased to incorporate the post of Insurance Medical Officer Gr. II (Homoeo) with a scale of pay of ₹ 22360-37940 below Insurance Medical Officer Gr. I (Homoeo) and the post of Insurance Medical Officer Gr. I (Ayur) with a scale of pay of ₹ 24040-38840 above Insurance Medical Officer Gr. II (Ayur) in the schedule of posts of Insurance Medical Services Department. Government are also pleased to modify the scale of pay of Insurance Medical Officer Gr. I (Homoeo) from ₹ 21240-37040 to ₹ 24040-38840 and that of Insurance Medical Officer Gr. II (Ayur) from ₹ 20740-36140 to ₹ 22360-37940. The schedule of posts of Insurance Medical Services Department at page 162 of Pay Revision Order 2009 shall stand modified to the above effect.

These orders will take effect from 1-7-2009.
