**S. R. O. No. 729/2012.**—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following rules further to amend the Special Rules for the Kerala Collegiate Education Subordinate Service issued under notification G. O. (P) No. 283/Public (Rules) Department dated 2nd September, 1967 and published in Part I of the Kerala Gazette No. 38 dated 26th September, 1967, namely:—

1. *Short title and commencement.*—(1) These rules may be called the Kerala Collegiate Education Subordinate Service (Amendment) Special Rules, 2012.

(2) They shall come into force at once.

2. *Amendment of the Rules.*—In the Special Rules for the Kerala Collegiate Education Subordinate Service,—

(i) in rule 1,—the heading “CLASS II A—POSTS IN GOVERNMENT POLYTECHNICS” and the category “Instructor in Physical Education (Physical Instructor) in Government Polytechnics” thereunder shall be omitted;

(ii) in rule 2,—the heading “CLASS II A—POSTS IN GOVERNMENT POLYTECHNICS” the category “Instructor in Physical Education (Physical Instructor) in Government Polytechnics” in column (1) and entries against it in column (2), shall be omitted;

(iii) in rule 3,—the word, figure and letter “Class II A” shall be omitted;

(iv) in rule 5 in sub-rule (1),—in the Table, the subheading, “Class II A” and the words, “Instructor in Physical Education (Physical Instructor) in Government Polytechnics” and the figure “36” against it shall be omitted;

(v) in the annexure referred to in sub-rule (2) of rule 5,—the category “Instructor in Physical Education (Physical Instructor) in Government Polytechnics” in column (1) and the entries against it in column (2), shall be omitted.

### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

In the Special Rules for the Kerala Collegiate Education Subordinate Service issued under notification G. O. (P) No. 283/Public (Rules) Department dated 2nd September, 1967 and published in Part I of the Kerala Gazette No. 38 dated 26th September, 1967, the post of “Instructor in Physical Education (Physical Instructor) in Government Polytechnics” comes under Class II A. The post of Instructor in Physical Education exist in Polytechnic Colleges and appointment to the post is being made by the Director of Collegiate Education. Most of the officers are appointed through by transfer method from the seniority list prepared by Director of Public Instruction. Direct recruitment is not possible to these posts. This affects the quality of Education. The method of appointment and service conditions are to be specifically provided in the rules. The Government have decided to bring the post under the control of the Director of Technical Education by de-linking it from the Department of Collegiate Education Subordinate Service and introduce a ratio for direct recruitment and by transfer appointment.

This notification is intended to achieve the above object.
