(iv) The candidates belonging to above reservation communities shall submit application for this post to the district where the vacancy is in existence for their community and shall note the name of that district against the relevant column in the online

application. Applications should not be submitted to more than one

district in response to this notification. If applications are submitted contrary to the above direction and if he/she is selected his/her name will be removed from the ranked list and disciplinary action will be taken against him/her.

- (vi) The selection in pursuance of the notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O.(MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district.
