**SECOND N.C.A .NOTIFICATION**

Applications are invited online only by “ONE TIME REGISTRATION” from qualified candidates belonging to Latin Catholic/Anglo Indian community in the State of Kerala for selection to the under mentioned post in Kerala Government service.

1. **Department** : **Collegiate Education**
2. **Name of Post** : **Lecturer in Islamic History**
3. **Scale of pay** : **U.G.C Scale**
4. **Number of vacancies** : **Latin Catholic/Anglo Indian – 1 (One)**

**Note:-**The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked to the above community but remains unfilled due to the paucity of candidates during the currency of the Ranked list published on 06.10.2009 for the post. This is the second NCA notification for the post owing to non availability of qualified candidates as per first NCA Notification (Gazette date: 31.12.2014, Category No. 712/14).

5. **Method of appointment** : **Direct Recruitment.** (Only from candidates belonging to Latin Catholic / Anglo Indian Community).

**NOTE:** Applications of candidates belonging to communities other than those mentioned in this notification will be summarily rejected. Individual rejection memo will not be sent to them.

6. **Age** : **22 – 43.** Only candidates born between 02.01.1973 and 01.01.1994 (both dates included) are eligible to apply. [For other conditions regarding age relaxations, please see Para 2 of the General conditions of the Gazette notifications, excluding para 2(i)]

- 7 **Qualifications** :

1. Masters Degree in the concerned subject (Islamic History) with not less than 55% marks or its equivalent and good academic record .
2. Must have passed a Comprehensive Test in the concerned subject specifically conducted for the purpose by UGC or any agency duly constituted by the state government in this behalf. When qualifications are being equal, preference shall be given to those candidates who possess adequate knowledge in Malayalam.

- Note: (i) For PhD holders who have passed Masters Degree prior to 19.09.1991, 50% marks for Masters Degree shall be sufficient. (GO (MS) No 2/07/H.Edn Dated 4.1.2007)
- (ii) Candidates who have obtained Ph.D Degree in the concerned subject are exempted from passing the NET examination. (G.O.(MS)No.86/07/H.Edn dated 19.06.2007)
- (iii) For recruitment to the above post, Degrees awarded by the Universities recognized by UGC alone shall be considered.
- (iv) KS & SSR part II Rule 10(a)ii is applicable.

**8. Mode of submitting Applications:-**

Candidates must register as per 'ONE TIME REGISTRATION' with the official Website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective post in the Notification Link to apply for the post. The Photograph uploaded should be taken on or after 31/12/2010. Name of the candidate and the date of photograph taken should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link, 'Registration Card' in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected at any stage if noncompliance with the notification is found in due course of processing. Documents to prove qualification, age, community etc have to be produced as and when called for.
