**5. Method of appointment: Direct Recruitment** (from among candidates belonging to Scheduled Tribe and L.C/A.I communities only)

**For ST candidates** : **21-47** (Only candidates born between 02.01.1969 and 01.01.1995) (both dates included)

**For L.C/A.I. candidates**: **21-45** (Only candidates born between 02.01.1971 and 01.01.1995) (both dates included)

## 7. Qualifications

- (1) M.B.B.S. Degree
- (2) Permanent Registration with the Travancore-Cochin Medical Council.
- Note: 1. Rule 10(a)(ii) of Part II KS &SSR is applicable.
  - 2. Candidates who have registered themselves with other State/Central Medical Council may also apply, but they will have to get themselves registered under Tranvancore Cochin Medical Practitioners Act before joining duty.
  - 3. Those who are appointed in the post should serve for four (4) years during the first 10 years of their service (including the period of training) anywhere in India or any Foreign Country under defence service or services connected with defence. Those who have completed 45 years of age will be exempted from the above compulsory Medical Service.

## **8.** Mode of submitting Applications:

Candidates who have registered can apply by logging on to their profile using their User-ID and Password. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information on their profile. They must quote User-Id for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The applications will be summarily rejected if non compliance with the notification is found in due course of processing.
