The above vacancies are now in existence. The Ranked List published as per this notification will be valid until candidates are advised and appointed against the vacancy earmarked to the above mentioned community, but remains unfilled due to the paucity of candidate and further such vacancy that may occur during the currency of the ranked list published on 08.10.13 for the post.

**Note:-**

i) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the service of any of the institutions under its purview if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of the candidate,provided that the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made with in the period of probation or 240 days from the date of joining duty whichever is earlier.

ii) The selection to the concern will be subject to the rules and regulations made from time to time.

5. Method of Appointment Direct Recruitment (Muslim, ST,LC/AI.OBC, Hindu Nadar, OX, Community only)

**Note:-** Applications of candidates belonging to communities other than those mentioned in this notification will be summarily rejected. Individual rejection memo will not be sent to them.

6. Age: 18 – 39 "Only candidates born between 02.01.1977 and 01.01.1998 (both dates included) are eligible to apply for this post.

For OX community: In the case of adult members of SC converted to Christian religion and their children , the upper age limit shall be 41 years. Candidates born between 02.01.1975 and 01.01.1998 (both days included) are eligible to apply for the post.

18-41 For ST Community(only candidates born between 02.01.1975 and 01.01.1998 (both dates included) are eligible to apply for this post.

Note : (i)

The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It should also be clearly specified in the certificate that they were not working in the regular service of the concern. The over aged candidates who become eligible to be included in the Ranked List on the basis of their provisional service in any Company/Corporation/ Board/Authority/Society will be considered only in the vacancies reported by the same concerned, in which they have worked provisionally.

(ii) The retrenched employees of the Kerala Fisheries Corporation will be given age relaxation as stipulated in the G.O.(Rt)No.1942/84/PW dtd. 31.12.1984 to the extent of their service subject to the condition that the maximum age limit shall not exceed 50 years. These candidates will also be given preference in the matter of recruitment among other candidates with equal marks. Such candidates should obtain a certificate from the Managing Director, Kerala Fisheries Corporation Limited to prove their length of service in the Company and the date of retrenchment and produce the same as and when required by the Commission.

2 **Must possess a Light Motor Driving Licence of atleast three years standing with endorsement for driving Light Duty Vehicles. Candidate shall possess a Current Driving Licence throughout all the stages of selection process as on the last date of application OMR test practical test Interview etc.**

Note:- Candidates called for the interview on the basis of the marks obtained in the practical test will have to produce a medical certificate in the prescribed form (in original) containing all the relevant details as mentioned in item No.7 above from Medical Officer not below the rank of Civil Surgeon.

Note: (i) Physically handicapped persons are not eligible to apply for the post.

(ii) Candidates should possess Current Driving Licence and Badge on the last date for receipt of applications in the office and also on the date of OMR test, Practical Test, Interview and at all stages of selection.

(iii) The proficiency in driving will be assessed by the Commission by conducting a practical test.

#### **8. Mode of submitting applications**

Candidates shall register as per 'ONE TIME REGISTRATION' system on the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' for applying for the post. Candidates who have already registered shall apply by logging on to their profile using their User- ID and password. Candidates shall click on the 'Apply Now' button of the respective posts in the Notification link to apply for a post. No application fee is required. Candidates can view and have a print-out of the details in the profile by clicking the link Registration Card, if required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Applications once submitted will be received as provisional and particulars shall not be deleted or altered after submission. The application will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove Qualification, experience, community, age etc. have to be produced as and when called for.
