# 5. Method of appointment : Direct Recruitment from Latin Catholics / Anglo Indians

- Note The applications of candidates belonging to other than the communities mentioned in this notification will be summarily rejected. Individual rejection memo will not be sent.
- 6 Age limit : 20-43. Only candidates born between 02.01.1972 and 01.01.1995 (both dates included) are eligible to apply for the post. [Including relaxations in para 2(1) of the General Conditions)

#### 7. Qualifications

- (i) Master's Degree in the concerned subject with not less than 50% marks from any of the Universities in Kerala or a qualification recognized as equivalent thereto by a University in Kerala.
- (ii) 1 B.Ed Degree in the concerned subject acquired after a regular course of study from any of the Universities in Kerala OR a qualification recognized as equivalent thereto by a University in Kerala.
  - 2 In the absence of persons with B.Ed. Degree in the concerned subject, B.Ed Degree acquired in the concerned faculty as specified in the Acts and Statutes of any of the Universities in Kerala.
  - 3 In the absence of persons with B.Ed. Degree as specified in item (1) and (2) above, persons with B.Ed. Degree in any subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognized as equivalent thereto by any of the Universities in Kerala
- (iii) Must have passed the State Eligibility Test for the post of Higher Secondary School

Teacher conducted by Government of Kerala or by the agency authorized by the State Government.

Note 1 Rule 10(a)(ii) of Part II of KS&SSR is applicable.

2 Persons who have acquired M.Ed in the concerned subject recognized by any University in Kerala are exempted from B.Ed qualification.

### Exemptions

- 1. Those persons who have passed the State Level Eligibility Test for the post of College Lecturers conducted by Government of Kerala are exempted from passing the State Eligibility Test for Higher Secondary School Teacher.
- 2. Those persons who have passed the National Eligibility Test/Junior Research Fellowship shall be exempted from passing the State Eligibility Test.
- 3. Persons with Ph.D/M.Phil/M.Ed. degree shall be exempted from passing the State Eligibility Test provided the M.Phil in the concerned subject should be one awarded by any of the Universities in Kerala or recognized as equivalent thereto by any of the Universities in Kerala.
- 4. The teachers who have completed 10(ten) years of approved teaching service at the High School level in the General Education subordinate service shall be exempted from passing the State Eligibility Test for Higher Secondary School Teachers.
- Note : Higher Secondary School Teacher (Junior) means part time post of Higher Secondary School Teacher.

#### 8. Mode of submitting Applications:-

Before applying for the post, candidates shall register as per "ONE TIME REGISTRATION" in the Official website of Kerala Public Service Commission www.keralapsc.gov.in. Those who have registered shall apply by logging in to their profile using their User-ID and Password. No application fee is required. Candidates can view, rectify defects and have print-outs of the details on the registration card by clicking the link **Registration Card** after entering the Home Page. Candidate are responsible for the correctness of the personal information and secrecy of password. They shall quote the user ID for further communication with the Commission. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected. Documents to prove qualification, age, community etc have to be produced as and when called for.
