FIRST NCA NOTIFICATION

Applications are invited online only exclusively from qualified candidates belonging to Viswakarma, LC/AI communities of Kerala State for appointment in the under mentioned post. Application must be submitted on line through the official website of Kerala Public Service Commission after 'One Time Registration'.

1. Department : **Excise**
2. Name of post : **Driver (HDV)**
3. Scale of pay : ₹ 9,190 – 15, 780/-
4. Number of vacancies : District wise (Community wise)
Palakkad – LC/AI – 01 (One) Category No: 152/2016
Kannur - Viswakarma – 1 (One) Category No: 153/2016

Note :-

- (i) Conventional type application for the above post will be summarily rejected. Candidates can apply through online application available at the Kerala Public Service Commission website viz. www.keralapsc.gov.in
- (ii) Applications submitted by candidates belonging to the community other than those notified will be summarily rejected. No rejection memo will be issued to these candidates.
- (iii) Separate Ranked lists will be prepared for above Districts in pursuance of this notification. Ranked List thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following district.

- (iv) Reservation community candidates shall submit application for this post to the concerned district where the vacancy is existing for their respective community and shall note the name of that district against the relevant column.
- (v) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O.(MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after 5 years, it will be subject to the rules in G.O.(MS)No. 4/61/PD dated, 02.01.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment (From candidates belonging to the above reservation communities only).
6. Age limit : 21- 42 Only candidates born between 2.1.1974 and 1.1.1995 (both dates included) are eligible to apply for this post. Including the relaxation as per para 2 (i) of General Conditions.

Note: For other conditions regarding age relaxation, please see para (2) of the General Conditions except para 2 (i). (Subject to the condition that the maximum age limit shall in no case exceed 50 years)

7. Qualifications:-

- 1 A Pass in Standard VII (New) or its equivalent.
- 2 Must possess current valid Heavy Duty Driving Licence of three years standing with endorsement for driving Heavy Goods/Passenger Vehicles and Badge.
- 3 Proficiency in Driving Heavy goods/passenger Motor Vehicles which is to be proved by a practical test including H test and Road test conducted by Kerala Public Service Commission during the course of selection. Only those who have passed 'H' test are eligible for Road Test.
- 4 Physical fitness:- Must not be less than 165 cm in height and 83 cm round the chest with a minimum expansion of 4 cm

Note:- KS&SSR Part II Rule 10 (a) ii is applicable.

(c) Muscles and joints : No paralysis, all joints with free movement.

Note :-

- (1) Candidates called for practical Test will have to produce a Medical Certificate in the prescribed form in original containing all relevant details as mentioned in item No 5 [except 5 (b) in para 7] above from a Medical Officer not below the rank of an Assistant Surgeon. A Medical certificate regarding eye sight mentioned in 5 b in para 7 above from an Ophthalmologist in Government Service also will have to be produced.
- (2) The Candidates will have to furnish the full details regarding the Driving Licence alongwith qualification in the application.
- (3) Differently abled candidates are not eligible to apply for the post.
- (4) Candidates should possess a current valid Driving Licence and badge through out all the stages of selection process viz on the last date of receipt of application, OMR test, on the date of practical test, interview etc.

- (5) Candidates from the ranked list prepared in response to this notification will be advised for appointment as per turn against Head Quarters vacancy also.
- (6) **Probation:-** Every person appointed to the post shall from the date on which he joins duty be on probation for a total period of 2 years on duty within a continuous period of 3 years.

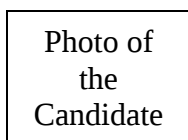

Specification for each eye should be stated separately. Special attention should be directed to the distant vision. Required standards of vision are as follows.

8. Mode of Submitting Applications:-

Candidates must register as per " ONE TIME REGISTRATION" with the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID

and password. Candidates must click on the `Apply Now' button of the respective posts in the Notification Link to applying for a post. The photograph uploaded should be one taken after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for.
