The proficiency in Swimming will be tested by a practical test conducted by the Commission.

Preferential:- Other conditions being equal, the Home Guard Volunteers who have completed a tenure of three years in that organizations and who have satisfactorily undergone training in Fire Fighting during the period of tenure shall be treated as having preferential qualification for direct recruitment to this post.

<u>Probation:</u>- Every person appointed to the post shall from the date on which he joins duty after he completes the training and examination will be on probation for a period of two years on duty within a continuous period of three years.

<u>Training:</u>- i) Training for a period of 6 months in the State Fire Service Training School or in any other institution as may be fixed, and pass the examination in the subject prescribed for the course.

- ii) After the above training Six months practical training at a Fire Station and a pass in the examination in the subjects prescribed for the course.
- Note: i) A written and practical test will be conducted during the last fortnight of the period of training at the close of training. Those who fail to qualify in either one or both tests shall have their training extended for a further period of one month, at the end of which they shall be tested again in the subjects in which they failed. The Director of Fire & Rescue service shall allow a third chance to pass the course to all fireman recruits who fail at the re-test.
- ii) Seniority among recruits, who have qualified in the test conducted by Fire and Rescue Services Academy shall be determined on the basis of effective advice of KPSC and they shall be appointed to service on the basis of seniority list, only after completion of successful training.

Bond:- A person appointed by direct recruitment to the post of Fireman shall execute a bond, binding himself to service in the department for a period of 7 years and to pay to Government an amount of Rs. 3000/- in case of failure to serve in the department for the said period.
