- 5 Method of appointment : Direct Recruitment only from candidates belonging to reservation group mentioned in this notification.

**Note:-** Applications of candidates belonging to Communities other than those mentioned in this notification will be summarily rejected. Individual rejection memo will not be sent to them.

- 6 Age limit : 23 - 39  
Only candidates born between 02-01-1976 and 01-01-1992 (both dates included) are eligible to apply. [For other conditions regarding age relaxations, please see Para 2 of the general conditions of the Gazette notifications, excluding para 2(i)]

- 7 Qualifications : Must possess a degree in Mechanical Engineering of a recognised University or equivalent qualification recognised by Central or State Government.

**Preferential :-** Two years experience in the manufacture and quality control of Boilers in a public enterprise or factory, directly controlled by any State or Central Government.

**Training:** Persons appointed to this post shall undergo an in-service training for a minimum period of Six months from the date of their joining in the Department. The period of in-service training will be counted for the period of probation and increment.
