- (iv) Reservation community candidates shall submit application for this post to the Malappuram district where the vacancy is existing for their respective community and shall note the name of that district against the relevant column.
- (v) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O.(MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after 5 years, it will be subject to the rules in G.O.(MS)No. 4/61/PD dated, 02.01.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

6. Age limit : 18- 42 Only candidates born between 2.1.1973 and 1.1.1997 (both dates included) are eligible to apply for this post. Including the relaxation as per para 2 (i) of General Conditions.
