1. **Department** : **Indian Systems of Medicine**
2. **Name of Post** : **Medical Officer (Nature-cure)**
3. **Scale of Pay** : **₹ 20740 – 36140/-**
4. **Number of vacancies** : **1 (One)**

The above vacancy is now in existence. 6. **Age limit** : 19-41, only candidates born between 02/01/1974 and 01/01/1996 (both dates included) are eligible to apply for the post with usual relaxation to SC/ST & OBC candidates

7. Qualifications:-

Degree in Naturopathy awarded by recognized Universities in Kerala or equivalent qualification

Note: - Rule 10 a (ii) of Part II, KS & SSR is applicable.

8. **Mode of submitting Application:-** Candidates must register as per 'ONE TIME REGISTRATION' with the official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to applying for a post. The Photograph uploaded should be one taken on or after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link **Registration Card** in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing.
