Applications are invited online only from qualified candidates for selection to the under mentioned post in Kerala Government Service. Before applying for the post candidates shall register as per the One Time Registration through the official website of Kerala Public Service Commission.

- 1. Department** : Kerala Collegiate Education (Music Colleges)
- 2. Name of Post** : Supporting Artist in Mridangam for Dance (Kerala Natanam)
- 3. Scale of pay** : Rs.15,380 - 25,900/-
- 4. No. of vacancies** : 1

Note:- 3% vacancies of the post shall be reserved for differently abled candidates (Locomotor disability / Cerebral Palsy, Blindness, Hearing Impairment / Low Vision) vide (G.O(P) 01/2013/SJD Dated 03/01/2013).

The above vacancy is now in existence. - 6. Age Limit** : 22-36. Only candidates born between 02/01/1979 and 01/01/1993 (both dates included) are eligible to apply for this post with usual age relaxation to Schedules Castes, Scheduled Tribes and Other Backward Communities. (For other conditions regarding the age relaxation please see para 2 of the General Conditions.

- 7 Qualifications** : First or Second Class in BA / Bachelor of performing Arts in Mridangam by recognized University / Institution.
- OR**
- SSLC and Diploma in Mridangam obtained after completion of a course of duration of four years from an Institution recognized by the Government.

Note: Rule 10(a) ii Part ii KS & SSR is applicable.

8. Mode of submitting Applications :

Candidates must register as per 'ONE TIME REGISTRATION' with official website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to applying for a post. The Photograph uploaded should be one taken on or after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, Experience, Community, Age etc have to be produced as and when called for.
