Applications are invited online only by One Time Registration from qualified candidates for the under mentioned post. Candidates shall apply only through the official website of the Kerala Public Service Commission.

**Note :-**

- (i) Conventional type applications for the post will be summarily rejected. Candidates shall apply only through online facility available at the Kerala Public Service Commission website viz [www.keralapsc.gov.in](http://www.keralapsc.gov.in).
- (ii) Separate Ranked list will be prepared for each districts in pursuance of this notification. The Ranked Lists thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said lists will continue to be in force till the publication of new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment in the ratio of 1:3 for by transfer and Direct recruitment against the aforesaid vacancies and also against the vacancies, if any, reported during the currency of the lists. In case no candidates is advised from the ranked list till the expiry of the period of three years the duration of the Ranked List shall be extended for a further period of one year or till at least one candidates is advised from the list whichever is earlier. In the absence of suitable candidates for appointment by transfer the vacancy shall be filled up by Direct recruitment.
- (iii) Applications should not be submitted to more than one district in response to this notification. If applications are submitted contrary to the above direction and if he/she is selected his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her. Candidates should note the name of the concerned District against the relevant column of the online application.
- (iv) The selection in pursuance of the notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O.(MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after 5 years, it will be subject to the rules in G.O.(MS)No. 4/61/PD dated, 02.01.1961. Candidates already in Government

service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment.
6. Age limit : 18-39. Candidates should have been born between 2.1.1976 and 1.1.1997 (both dates included) . Other Backward Communities and SC/ST candidates are eligible for usual relaxation.

Note: For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years. Please see para (2) of the General Conditions under Part II of this notification.

7. Qualifications:-

1. A Pass in Standard VII/III Forum.
2. Must possess valid Driving Licence of three years standing to drive Medium/Heavy Good/Passenger Motor Vehicle with Driver's badge.
3. Proficiency in Driving-Medium/Heavy Good/Passenger motor vehicles which is to be proved in a practical test including (H-test) conducted by KPSC during the course of selection.

**Note:** KS & SSR Part II Rule 10 (a) ii applicable.

4. Medical Fitness :-

- (a) Ear : Hearing should be perfect.
- (b) Eye
- Distant Vision : 6/6 Snellen
- Near Vision : 0.5 Snellen
- Colour Vision : Normal
- Night blindness : Nil
- (c) Muscles and joints : No paralysis, all joints with free movement.
- (d) Nervous System : Perfectly normal and free from any infectious diseases.

Note:

- (a) Candidates called for practical Test will have to produce a Medical Certificate in the prescribed form in original containing all relevant details as mentioned in item No 4 [except 4 (b) in para 7 above from a Medical Officer not below the rank of an Assistant Surgeon]. A Medical certificate regarding eye sight mentioned in 4 b in para 7 above from an Ophthalmologist in Government Service also will have to be produced.
- (b) The Candidates will have to furnish the full details regarding the Driving Licence and experience in driving alongwith qualification in the application.
- (c) Physically Handicapped candidates are not eligible to apply for the post.
- (d) Candidates should possess a current valid Driving Licence and badge through out all the stages of selection process namely on the last date of receipt of application, OMR test practical test and interview etc.
- (e) Candidates from the R/L prepared in response to this notification will be advised for appointment as per turn against HQ vacancies also.

Probation :Every person appointed to the post shall, from the date on which he joins duty be on probation for a total period of 2 years on duty within a continuous period of three years.

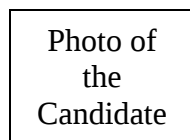

Note:- Details regarding standards of vision shall be clearly stated in the certificate, as given above and vague statements such as vision Normal etc. will not be accepted. Specification for each eye should be stated separately. Special attention should be directed to the distant vision. Required standards of vision are as follows.

Each eye must have full field of vision.

**8. Mode of Submitting Applications:-**

Candidates must register as per “ONE TIME REGISTRATION” with the official website of Kerala Public Service Commission viz. [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. posts in the Notification Link to applying for a post., No application fee is required. Candidates can view and have a print out of the details in the profile by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote the User – ID for further communication with the Commission. Applications submitted is provisional and cannot be deleted or altered on after submission. The application will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for.
