- (iv) This third NCA Notification is issued due to the paucity of eligible candidates as per I st NCA Notification (Gazette dtd. 30.08.2010, Cat.No.231/2010) and II nd NCA notification (Gazette dtd. 15.12.2012, Cat.No. 636/2012)
- (v) The candidates belonging to above reservation community shall submit application for this post to district Officer concerned and shall note the name of that district against the relevant column in the online application.
- (vi) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G O (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the
