- (iv) The third NCA Notification is issued due to the paucity of candidates belonging to above community after the issuance of the First NCA Notification vide category No.162/2010 and the Second NCA Notification vide category No. 184/2012
- (v) The candidates belonging to Ezhava community shall submit application for this post to Kozhikode district only where the vacancy is in existence for their community and shall note the name of that district against the relevant column in the online application.
- (vi) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G O (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G O (MS) No.4/61/PD, dated 2.1.1961. Candidates already in Government Service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

- 6. Age Limit :- 18-39. Only Ezhava Candidates born between 02.01.1976 and 01.01.1997 (both dates included) are only eligible to apply for this post.
