**FOURTH NCA NOTIFICATION**

Applications are invited online only from qualified candidates belonging to reservation group of communities of Kerala State viz OX for appointment in the under mentioned post. Application must be submitted online through the Official website of the Commission after One Time Registration. Candidates who have already registered can apply through the profile

1. Department : Indian Systems of Medicine
2. Name of Post : Pharmacist Grade II (Ayurveda)
3. Scale of pay : Rs.6,080 – 9,830/-
4. Number of vacancies : District wise  
Malappuram – OX – 1 (one)

*Note:-*

- (i) Conventional type applications for the above post will be summarily rejected. Candidates shall apply only through online facility available at the Kerala Public Service Commission website viz [www.keralapsc.gov.in](http://www.keralapsc.gov.in).
- (ii) Applications submitted by candidates belonging to the community other than those notified will be summarily rejected. No rejection memo will be issued to these candidates.
- (iii) A Ranked List will be prepared for Malappuram District in pursuance of this notification. Ranked List thus prepared and published by the Commission shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following date in following district.

- (iv) The fourth NCA Notification is issued due to the paucity of candidates belonging to the above community after the issuance of the first NCA notification vide Category No. 158/09, the 2<sup>nd</sup> NCA Notification vide Category No. 178/11 and 3<sup>rd</sup> NCA Notification vide Category No. 58/2014.
- (v) The candidates belonging to above reservation community shall submit application for this post to the Malappuram district where the vacancy is in existence for their community and shall note the name of that district against the relevant column in the online application.

(vi) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O. (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G O (MS) No. 4/61/PD, dated 2.1.1961. Candidates already in Government service holding the same post in any one district are prohibited from applying again for this post. But they can apply to higher posts when notified.

- 5 Method of appointment : Direct Recruitment (From candidates belonging to Other X'ian Communities only)
- 6 Age Limit : 18-39. Only candidates born between 02.01.1976 & 01.01.1997 (both dates included) are eligible to apply.

Note:- 18-41 – Only candidates born between 02.01.1974 and 01.01.1997 (both dates included) are eligible to apply for the post in the case of OX candidates who have converted to Christianity from the adult member of SC communities and their children.  
(Including the relaxation as per para 2 (i) of the General Conditions)

**Note:-** For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para 2 of the General Conditions under Part II of this Notification except para 2 (i).

7. Qualifications:

- (1) S.S.L.C. OR equivalent qualification
- (2) Certificate in Ayurveda Pharmacist Course recognized by the Government of Kerala.

**Note:-** KS & SSR Part II Rule 10 (a) (ii) is applicable.

8. Last date of receipt of applications : **14.10.2015 Wednesday up to 12 midnight**
9. Mode of submitting Applications:-

Candidates must register as per “ ONE TIME REGISTRATION” with the Official Website of Kerala Public Service Commission '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)' before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to applying for a post. The photograph uploaded should be one taken on or after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on

their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for.

10. If a Written Test/OMR Test is conducted as part of the selection Admission Tickets of eligible candidates will be made available in the website of Kerala Public Service Commission. Candidates are instructed to download their Admission tickets as per the instructions given in the website.
