- (iii) The candidates shall submit application for this post to Kasaragod District where the vacancy for the community is in existence and note the name of that district against the relevant column in the online application.
- (iv) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G O (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G O (MS) No.4/61/PD, dated 2.1.1961. Candidates already in Government Service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

- **6.** Age Limit :- 20-39. Only candidates born between 2.1.1977 and 1.1.1996 (both dates included) are eligible to apply for this post. Including the relaxation as per para 2 (i) of General Condition.

- 1. A pass in plus Two/Pre-Degree (With Science Subjects) Course/pass in VHSE (with Science Subjects)/VHSE in Domestic Nursing of a recognized University or its equivalent.
- 2. A pass in Bsc Nursing of a recognized University or a pass in General Nursing and Midwifery Course having not less than 3 years duration from any institution recognized by Government.
- 3. Certificate of Registration with Kerala Nurses and Midwives Council as Nurse and midwife, in the case of woman candidates and as Nurse in the case of male candidates.
