- Notes : (i) Conventional type applications for the post will be summarily rejected. Candidates shall apply only through the online facility available at the Kerala Public Service Commission website viz <u>www.keralapsc.gov.in.</u>
 - (ii) A Ranked List will be prepared for Kannur district in pursuance of this notification. The Ranked list thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancy and also against the vacancies, if any, reported during the currency of the list. In case no candidate is advised from the ranked list till the expiry of the period of one year or till at least one candidate is advised from the list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.
 - (iii) Candidates shall submit application for this post to the Kannur district and shall note the name of that district against the relevant column in the online application.
 - (iv) The selection in pursuance of the notification will be made on a revenue district basis, subject to the special conditions laid down in G.O. (Ms)No.154/71/PD dated, 27.05.1971.
