(iv) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O (Ms) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS) No.4/61/PD dated, 02.01.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of Appointment

 Direct Recruitment (from male candidates belonging to OBC, OX and Hindu Nadar communities only)

6. Age

19-34. Candidates born between 2.1.1982 and 1.1.1997 (Both dates included) are eligible to apply for the post in the case of OBC, OX and Hindu Nadar (Including the age relaxation as per Para 2(i) of the General Conditions)

19-36: Candidates born between 02.01.1980 and 01.01.1997 (both dates included) are eligible to apply for this post in case of OX candidates who have converted to Christianity from SC Communities after attaining 18 years and children of such parents.

For other conditions regarding age relaxation, please see Para (2) of the General Conditions except Para 2(i) under Part II of this notification.

7. **Qualifications** :-

I Must have passed the Plus Two examination or its equivalent.

[KS & SSR Part II Rule 10(a)(ii) is applicable.]

- II Must not be less than 165 cms in height and 81 cms round the chest with a minimum expansion of 5 cms.
- III Must be certified by a Medical Officer not below the rank of an Assistant Surgeon as to his physique fitness and capacity for active outdoor work. The Medical Certificate has to be produced as and when called for.

Note:

(i) In the case of direct recruitment, preference shall be given to Exserviceman.

- (ii) Candidates appointed by direct recruitment will be on probation for a period of two years on duty within a continuous period of three years and the candidates appointed shall undergo a training as may be prescribed by the Commissioner of Excise for a period of not less than 6 months, subject to the minimum of 180 working days. The period of training shall count for probation and increment. Who did not undergo basic training within a period of two years and those who didn't successfully complete the basic training shall not be considered for further promotion.
- (iii) Every person deputed for training shall execute a bond agreeing to complete the course of training and to serve the Government after training for such minimum period as may be specified by the Commissioner of Excise, failing which he shall be liable to refund the cost of training together with liquidated damage.
- (iv) The conditions laid down in sub para VII of the para 2 and para 5 of the General conditions are not applicable for this post.
- (v) NCC Cadets having `A' `B' & `C' Certificates will be given weightage marks at the rate of 2%, 3% and 5% respectively.

The Physical measurement of candidates will be taken at the time of physical efficiency test and those who do not possess the prescribed physical measurement will not be admitted for the physical efficiency test. If accidents or injuries happen to a candidate while participating in the Physical Efficiency Test, he will not be given further chance to participate in the test.

8. Mode of submitting applications:-

Candidates must register as per 'ONE TIME REGISTRATION' with the official Website of Kerala Public Service Commission viz., www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be one taken on or after 31/12/2010. Name of the candidate and the date of taking

photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link 'Applications' in their profile. Candidates are responsible for the correctness of their personal information and secrecy of password. Before the final submission of the application, candidates must ensure correctness of the information they have entered. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, Experience, Community, age etc. have to be produced as and when called for.
