### **THIRD NCA NOTIFICATION**

Applications are invited through One Time Registration Scheme only from qualified candidates belonging to the following reservation group in Kerala State for appointment in the under mentioned post in Kerala Government Service. The Third NCA Notification is issued due to the paucity of eligible candidates as per I NCA Notification (Gazette date 16.04.2012, Category No. 73/12.) and Second NCA notification (Gazette date 15.10.2013, Category No. 354/2013).

1. **Department** : **Higher Secondary Education**
2. **Name of Post** : **Higher Secondary School Teacher (Junior) Sanskrit**
3. **Scale of pay** : **₹16180-29180/-**
4. **Number of vacancies** : **Latin Catholic - 2 (Two)**

The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked to the above community but remains unfilled due to the paucity of candidates during the currency of the ranked list published for the post with effect from 21.12.2011 (Category No. 203/2005, Gazette date 14.11.2005)

5. **Method of appointment** : **Direct Recruitment** (from candidates belonging to the reservation group of Latin Catholic)

Note The applications of candidates belonging to other than the community mentioned in this notification will be summarily rejected. Individual rejection memo will not be sent to them.

6. **Age limit** : 20-43. Only candidates born between 02.01.1972 and 01.01.1995 (both dates included) are eligible to apply for the post. (Including relaxations in para 2(i) of the General Conditions) (For other conditions regarding age relaxation, please see Para (2) of the general conditions except Para 2 (i).)

#### 7. **Qualifications:-**

- I Master's Degree in the concerned subject with not less than 50% marks from any of the Universities in Kerala or a qualification recognized as equivalent thereto in the respective subject by a University in Kerala.
- II (i) B.Ed Degree in the concerned subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognized as equivalent thereto by a University in Kerala.  
(ii) In the absence of persons with B.Ed. Degree in the concerned subject, B.Ed Degree acquired in the concerned faculty as specified in the Acts and Statutes of any of the Universities in Kerala.  
(iii) In the absence of persons with B.Ed. Degree as specified in item (i) and (ii) above,

persons with B.Ed. Degree in any subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognized as equivalent thereto by any of the Universities in Kerala

III Must have passed the State Eligibility Test for the post of Higher Secondary School Teachers conducted by Government of Kerala or by the agency authorized by the State Government.

- Note
- 1 Rule 10(a)(ii) of Part II KS&SSR is applicable.
  - 2 In the absence of B.Ed Degree holders, candidates having Master's Degree with not less than 50% marks and who have passed the State Eligibility Test will be considered. Preference will be given to those who have acquired Ph.D/M.Phil. Degree or qualified at Junior Research Fellowship/National Eligibility Test. The teachers appointed under this provision will have to acquire B.Ed Degree at their own expense within five years from the date of entry in service.
  - 3 Those who have passed Language Teachers Training Course are exempted from acquiring B.Ed. qualification.
  - 4 Persons who have acquired M.Ed. in the concerned subject recognized by any University in Kerala are exempted from B.Ed. qualification.

### **Exemptions**

1. Those persons who have passed the State Level Eligibility Test for the post of College Lecturers conducted by Government of Kerala are exempted from passing the the State Eligibility Test for Higher Secondary School Teachers.
2. Those persons who have passed National Eligibility Test/Junior Research Fellowship shall be exempted from passing the State Eligibility Test.
3. Persons with Ph.D/M.Phil/M.Ed. degree shall be exempted from passing the State Eligibility Test provided the M.Phil in the concerned subject should be one awarded by any of the Universities in Kerala or recognized as equivalent thereto by any of the Universities in Kerala.
4. The teachers who have completed 10(ten) years of approved teaching service at the High School level in the General Education subordinate service shall be exempted from passing the State Eligibility Test.

### **8. Mode of submitting Applications:-**

Before applying for the post, candidates should register as per "ONE TIME REGISTRATION" Scheme through the Official website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in). Those who have already registered can apply by logging in to their profile using his/her User-ID and Password. No application fee is required. Candidates can view, rectify defects and print the details in the registration card by clicking the link **Registration Card** after entering the home page. Candidate are responsible to ensure correctness of the personal information and secrecy of password and they shall keep in mind the user ID for further communication with the Commission. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected. Documents to prove qualification, age, community etc have to be produced as and when called for.
