Applications submitted by candidates belonging to the communities other than those notified will summarily be rejected. No rejection memo will be issued. In the absence of Scheduled Caste candidates, candidates belonging to Scheduled Tribe will be considered.

The selection in pursuance of this notification will be made on Revenue District basis,

subject to the special conditions laid down in GO(MS) No. 154/71/PD dated, 27.5.1971. A candidate advised for appointment in one Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5years continuous service from the date of commencement of service in the former District. Even if transfer is allowed after 5 years, it will be subject to the rules in GO (MS) No 36/91/P&ARD, dated 02.12.1991.

Candidates already in Government Service holding the same post in any one district are prohibited from applying again for this post.

Candidates will be advised from the Ranked list for appointment against the Headquarters vacancies also. Such candidates will be eligible for transfer to another district as per the terms and conditions in G.O.(MS) 442/80/GAD dated 26/09/1980. As selection to this post is exclusively made for Ex-Servicemen, candidates advised subsequently for appointment from a particular district will not be eligible for Interdepartmental transfer as per G.O.(P) 51/90/P&ARD, dated 22/11/1990.

Applications shall not be submitted to more than one district in response to this notification. If applications are submitted in violation to the above direction, and if the candidate is selected, his/her name will be removed from the ranked lists and disciplinary action will be taken against him/her.

5. Method of appointment: Direct Recruitment

(From ex-servicemen of SC reservation group of community only). In the absence of Scheduled Caste candidates, candidates belonging to Scheduled Tribe will also be considered.

6. Age limit : 18 - 50

Candidates born between 02/01/1965 and 01/01/1997 (Including both dates) only are eligible to apply for the post. (Including the period of Military Service and also subject to the eligibility of age relaxation to the Ex-serviceman)

For conditions regarding other age relaxation, please see para 2 of the General Conditions except para 2 (I) and (vi).

Note:-

Relaxation in upper age limit will not be allowed to this post.

Attested true copies of the military discharge certificates should be produced as and when called for by the Commission.

Candidates who are selected for appointment as per this notification should not have completed 56 years of age while joining duty.

7. Qualifications:

Pass in SSLC or its equivalent.

Lower Grade Certificate in Typewriting Malayalam (KGTE).

Lower Grade Certificate in Typewriting English (KGTE) and Computer Word Processing or its equivalent (IMC Certificate in Typewriting will not be accepted).

Those who have passed KGTE Typewriting before January 2002 should produce separate certificate in Computer Word Processing or its equivalent. Certificate in Computer Word Processing issued by Central/State Government Department/Agencies/Societies/Universities after successfully completing course of study not less than three months duration are considered as equivalent.

Malayalam Typewriting lower is not compulsory for the Ex-servicemen for applying to the post of Typist in the Government service. But if they are selected, the above qualification should be acquired before completing probation.

Ex-servicemen with service as Clerk (General duties) Clerk (Staff duties) Clerk (A.O.C) and personal Assistants in the Army, Writers in the Navy and Clerks (General duties) in the Air Force, who were under the Category "Class I" or those who posses 15 years service in the Clerical cadre in the Defence Forces will be treated as eligible to apply for this post. (G.O(P) 143/77/GAD dated 18.5.1977, G.O(P) No. 35/79/GAD dated 6.1.1979, G.O. (P) No.143/86/GAD dated 30/04/1986). The service period of 15 years which makes one qualified for the post, will not be considered for the award of weightage marks.

Service as Clerk/Writer in the Defence forces as detailed in notes above for not less than 15 years will be deemed as sufficient qualification for the post. If selected, they have to pass Malayalam Typewriting (Lower) before completing probation.

Subject to the conditions laid down in GO(P) NO. 139/77/GAD dated 11/05/77, linguistic minority candidates whose first language for SSLC examination is a language other than Malayalam may apply to this post even if they do not possess Malayalam Typewriting (Lower) qualification. If selected, they have to acquire Malayalam Typewriting (Lower) qualification before completion probation.

Certificates obtained from Government alone will be accepted as proof of Typewriting qualification(Certificates obtained from the Typewriting Institute will not be accepted)

KS&SSR Part II Rule 10 a (ii) is applicable for selection to this post.
