Applications are invited online only by One Time Registration from qualified candidates belonging to OX/Dheevara community for selection to the under mentioned post.

1. Department : Education
2. Name of Post : High School Assistant (Physical Science) - Kannada Medium.

**Note:-**

- (i) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued.
- (ii) A Ranked list will be prepared for Kasaragod district in pursuance of this notification. Ranked List thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above communities, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following district.

- (iii) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O (Ms) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he or she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS) No.4/61/PD dated, 02.01.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment (from candidates belonging OX/ Dheevara communities only).
6. Age Limit : 1) 18-43. Only candidates born between 02.01.1972

and 01.01.1997 (Both dates included) are eligible to apply for this post in the case of OX and Dheevara. [The relaxation as per Para 2(i) of General Conditions are included].

- 2) 18-45. Only candidates born between 02.01.1970 and 01.01.1997 (Both dates included) are eligible to apply for this post (NCA OX) in the case of adult members belonging to any of the Scheduled Caste who are converted to Christianity and children of such parents.

Note:- For conditions regarding other age relaxation please see para 2 of the general conditions, except para 2 (i).

7. Qualifications:

A Degree in the concerned subject and B.Ed/BT in the concerned subject conferred or recognized by the Universities in Kerala. (Concerned subject are specified in Note 3 below.

Note:-

- 1 Post Graduates in concerned subject are also eligible to apply for the post, if they possess BEd/BT in the concerned subject.
- 2 Diploma in Rural Service awarded by the National Council for Rural Higher Education will also be treated as equivalent to Degree for the above purpose.
- 3 The applicant should have taken physics/Chemistry as main subject for graduation. Degree in Geology (Main) with Physics and Chemistry as subsidiary subjects and B.Ed. Degree (Physical Science) can also be considered as an alternative qualification for the post [G.O (Ms) No 195/96/G.Edn dated 2.7.1996].
- 4 Post title degree holders are not eligible to apply for the post of High School Assistant.
- 5 If there is a written (Descriptive/OMR) test the Question paper for the written test will be in Kannada. For the written Test, the candidates should answer the questions in Kannada. Knowledge in Kannada will also be tested at the time of interview.
- 6 Those candidates who secured B.Ed/B.T Degrees from the Universities outside Kerala shall produce, relevant orders declaring the said degree as equivalent to those prescribed for this selection before the commission when called for.

Rule 10 a (ii) of Part II of KS & SSR is applicable.

8. SPECIAL CONCESSIONS REGARDING APPOINTMENT AND AGE LIMIT

- (i) Preference will be given as laid down in G.O.(MS) No. 50/70/PD dated 12.02.1970 and G.O.(MS) No. 9/78/G.Edn. Dated 21.01.1978 to the wives of Jawans in the matter of recruitment as Teachers, if they possess the prescribed qualifications. Soldiers in active service and those working in Base Establishment are included under the term `Jawans'. Wives of Jawans should note in the application that they are wives of Jawans. Such candidates should obtain proper certificates from the Officer Commanding stating the name, military rank and military address of their husbands and produce the same as and when required by the Commission (G.O (MS) No. 509/64/Edn. Dated

19.09.1964, G.O.(MS) No. 614/65/Edn. Dated 09.11.1965 and G.O (MS) No. 243/66/Edn. Dated 27.05.1966).

(ii) First Class Scouts and Guides will be given preference in the matter of appointment as Teachers (G.O (MS) No. 122/75/G.Edn. Dated 27.05.1975).

(iii) Teachers of the Government Primary and Nursery Schools who are graduates and are otherwise qualified will be exempted from upper age limit (G.O (Ms) No 185/70/Edn dated 18.4.1970 and G.O (Ms) No 466/70/Edn dt 11.11.1970). They should produce proper certificates from authorities concerned as and when required by the Commission.

Note:- The candidates who claim concessions by virtue of any of the above or any reason mentioned in Para 2 of the General Conditions should state "Are you eligible for age relaxation" as "yes" on the online application and give details. Otherwise the applications are liable to be rejected presuming that they are over aged candidates.

10. Mode of Sending Application :

Candidates must register as per "ONE TIME REGISTRATION" with the Official Website of Kerala Public Service Commission '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)' before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to applying for a post. The photograph uploaded should be one taken on or 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for.
