- (iii) Separate Ranked List will be prepared for Thiruvananthapuram, Thrissur and Kannur Units in pursuance of this notification. The Ranked List thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. In case no candidate is advised from the ranked list till the expiry of the period of three years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.
- The selection in pursuance of the notification will be made on a Unit basis, (iv) subject to the special conditions laid down in G.O (Ms)No.92/80/Home dated 24.09.1980. All postings and transfers of members of the service shall be made by the IG of prisons. Candidates already in Government service holding this post in anyone unit are prohibited from applying again for this post, but they can apply to higher posts when notified.
