5. Method of appointment : Direct Recruitment (from among candidates belonging to Other Christians (OX) only)

NOTE: Applications submitted by candidates other than OX Community will be rejected. Individual communication regarding the rejection of their application will not be issued.

6. Age : 21-45 [Only candidates born between 02.01.1971 and 01.01.1995 (both dates included) are eligible to apply for the post (including the relaxation as per para 2(i) of the General conditions)

Note : In case of adult members of Scheduled Caste converted to Christian religion and their Children, the Upper age limit shall be 47 years. i.e. candidates born between 02.01.1969 and 01.01.1995.

7. Qualifications

- 1. M.B.B.S. Degree
- 2. Permanent Registration with the Travancore Cochin Medical Council
- Note: 1. Candidates who have registered themselves with other State/Central Medical Council may also apply, but they will have to get themselves registered under Tranvancore Cochin Medical Practitioners Act before joining duty.

2. Those who were appointed in the post should serve for four (4) years during first 10 years of their service (including the period of training) anywhere in India or any Foreign Country under defence service or services connected with defence. Those who have completed 45 years of age are exempted from the above compulsory Medical Service.

Note : Rule 10 (a) (ii) of Part II KS & SSR is applicable.
