The Ranked List prepared in pursuance of this notification is intended to make recruitment to the backlog vacancies earmarked for the various categories of PH candidates as per <u>GO (P) No 7/2011/SWD dated 24/01/2011</u> and will remain in force for a maximum period of three years subject to the condition that the ranked list will cease to exist as and when candidates are advised and appointed against the above mentioned vacancies. Rules 14 to 17 of Part II, KS&SSR are not applicable to this selection.

Candidates will be advised and appointed against the above mentioned vacancies and also against the backlog vacancies, if any, reported by the Appointing Authorities as earmarked in GO(P) No 7/11/SWD dated 24/01/2011.

Selection to the above-mentioned vacancies will be made from among the (Locomotor Disability/Cerebral palsy, Hearing impairment and Low vision) PH categories found suitable for the post as per existing government orders and vacancies will be apportioned among these categories in the ratio 1:1:1.

: **Direct Recruitment from among the PH** (Locomotor Disability/Cerebral Palsy, Hearing Impairment and Low Vision) candidates only.

- 6. Age limit

- : 1. Hearing Impairment and Low Vision candidates: 18-50. Only candidates born between 02.01.1965 and 01.01.1997 (both dates included) are eligible to apply for the post.
 - 2. Locomotor Disability/Cerebral Palsy candidates 18 47. Only candidates born between 02.01.1968 and 01.01.1997 (both dates included) are eligible for this post.
- **7. Qualifications**: Diploma in Civil Engineering of the Kerala University or Diploma recognised by Government as equivalent thereto

Note:- Rule 10 (a) ii of Part II, KS & SSR is applicable.

8.
