Candidates will be advised for appointment against aforesaid vacancy and also against the vacancies if any reported during the currency of the list. In case no candidates is advised from the Ranked list till the expiry of the period of three years, the duration of the Ranked list shall be extended for a further period of one year or till at least one candidates is advised from the list whichever is earlier.
- (ii) The selection in pursuance of the notification will be made on a revenue district basis, subject to the special conditions laid down in G.O. (Ms)No.154/71/PD dated, 27.05.1971.
