 - (ii) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued to these candidates.

- (iv) The second NCA notification is issued due to the paucity of candidates belonging to the above community after the issuance of first NCA notification vide Cat No. 497/14 (Idukki, Ernakulam SIUC Nadar), 502/14 (Kozhikode OX), 503/14 (Kozhikode Dheevara) respectively.
- (v) Candidates shall submit application for this post only to anyone district where the vacancy is in existence for their community and shall note the name of that district against the relevant column in the online application. Applications should not be sent to more than one district in response to this notification. If applications are sent contrary to the above direction, and if the candidate is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her.
- (vi) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even

if transfer is allowed after five years, it will be subject to the rules in G O (MS) No.4/61/PD, dated 2.1.1961. Candidates already in Government Service holding the same post in the same department in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

7. Qualifications:-

- (i) A pass in S.S.L.C or its equivalent qualification.
- (ii) A Certificate obtained after successful training in Nurse Cum Pharmacist Training Course (Homoeopathy) conducted by the Government of Kerala or its equivalent.

Note:- KS&SSR Part II Rule 10 a (ii) is applicable for selection to this post.

8. Mode of submitting Applications:-
