Note:- (i) Conventional type applications for the above post will be summarily rejected. Candidates shall apply only through online facility available at the Kerala Public Service Commission website viz www.keralapsc.gov.in.

- (ii) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued to these candidates.
- (iii) Separate Ranked Lists will be prepared for the above districts (Kollam & Malappuram) in pursuance of this notification. Ranked List thus prepared and published by the Commission shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following dates in following districts.

- (iv) The third NCA notification is issued due to the paucity of candidates belonging to the above community after the issuance of first NCA notification vide Cat No. 199/13 (Kollam LC), 201/13 (Malappuram Dheevara) and Second NCA Notification vide Cat. No. 284/15 (Kollam LC), 285/15 (Malappuram Dheevara) respectively.
- (v) Candidates shall submit application for this post only to anyone district where the vacancy is in existence for their community and shall note the name of that district against the relevant column in the online application.
- (vi) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G O (MS) No.4/61/PD, dated 2.1.1961. Candidates already in Government Service holding the same post in the same department in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

- 5. Method of appointment :- Direct Recruitment (From candidates belonging to Latin Catholic & Dheevara communities only)
- 6. Age Limit :- 18-39. Candidates born between 02.01.1977 and 01.01.1998 (both dates included) are eligible to apply for this post. (Including the relaxation as per Para 2(i) of the General Condition).

- (i) A pass in S.S.L.C or its equivalent qualification.
- (ii) A Certificate obtained after successful training in Nurse Cum Pharmacist Training Course (Homoeopathy) conducted by the Government of Kerala or its equivalent.

Note:- KS&SSR Part II Rule 10 a (ii) is applicable for selection to this post.

8. Mode of submitting Applications:-

Candidates must register as per "ONE TIME REGISTRATION" scheme through the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have already registered can apply by logging in to their profile using their User-ID and password. Name of the candidate and the date of taking photograph should be printed at the bottom portion. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing.
