Applications submitted in any other manner will not be considered. The original chalan receipt together with the application for rechecking should reach the District Officer, K.P.S.C. District Office, Kollam within 45 days from the date on which this Ranked List is brought into force. The fee once remitted will not be refunded on any account.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of **Rs. 300/- (Rupees Three Hundred Only) by way of chalan** in any of the Treasuries in the State under the **Head of Account 0051 PSC-800-State PSC-99 Other receipts**. The duly filled up application in the prescribed form (available from the Commission's website) along with the original chalan should be submitted to the District Officer ,KPSC District Office ,Kollam within **45** days from the date on which the ranked list is brought into force. **A copy of the answer sheet will be issued only once to a candidate.** Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Any candidate can relinquish his/ her right for appointment in writing duly attested by a Gazetted Officer of State /Central Government with signature, name, designation and office seal,and an affidavit certified by notary and a self attested copy of photo affixed ID CARD. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisition of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised.
