Note :- (5) Candidates belonging to Other Backward Classes included in this list who are required to produce Non – Creamy Layer Certificate as per G.O (P) No: 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with the other documents mentioned above at the time of verification of original documents.SC/ST candidates included in the short list are required to produce Community Certificate issued under rule 4 of Kerala(scheduled caste and Scheduled Tribes) Regulation of issue of Community Certificate rules,2002 by the Revenue Authorities not below the Rank ofTahsildar.
