Note :- (5) Candidates belonging to Other Backward Classes included in this list who are required to produce Non - Creamy Layer Certificate as per G.O (P) No: 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with the other documents mentioned above at the time of verification of original documents.SC/ST candidates included in the short list are required to produce Community Certificate issued under rule 4 of Kerala(scheduled caste and Scheduled Tribes) Regulation of issue of Community Certificate rules,2002 by the Revenue Authority.

Note :- (6) Copy of answer scripts of the OMR Test held on **17/12/2016** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : **ER VII(1)3281/17/EW DATED 29/12/17.**
