### NOTIFICATION

This is to notify that there is no eligible candidate available to be included in the Ranked List for the post of **LD CLERK (EX-SERVICEMEN ONLY)- (BY TRANSFER from Low Paid Employees of NCC/ SAINIK WELFARE Departments)** (Category No: 373/2015) in **NCC and SAINIK WELFARE Departments** on Rs. 9940-16,580/- in Thrissur District in response to the notification published in the Gazette dated 30/10/2015.

According to the existing procedure, revaluation of answer script is not allowed. But rechecking of marks will be done on payment of **₹75/- (Rupees Seventy Five only)**. The fees should be remitted in any one of the Treasuries in the State by chalan under the Head of Account **"0051 PSC 105 STATE PSC-99 EXAMINATION FEE"**. The fee once remitted will not be refunded on any account. The result of the rechecking will be intimated to the candidates from this office.

Application for re-checking of answer scripts should be submitted in the prescribed format available free of cost from the Enquiry Section of the various offices of the Kerala Public Service Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website: [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or photocopied there from. Applications submitted in any other manner will not be considered. Candidates who wish to obtain a Photocopy of their OMR answer sheet (Part A and Part B) relating to this selection shall remit the fees of **₹300/- (Rupees Three Hundred only)** in any one of the Treasuries in the State by chalan under the Head of Account **"0051-PSC-800 STATE PSC - 99 OTHER RECEIPTS"**. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own and legal proceedings will be initiated against those who do so.

Valid applications for re-checking/ obtaining photocopy of answer script addressed to the District Officer, Kerala Public Service Commission District Office, Thrissur shall reach this office within **45 days** from the date on which the Ranked List has come into force (i.e. the date on which the Ranked List has been approved by the commission). The last date for receipt of applications for rechecking/ obtaining photocopy of the answer script is **10.05.2018**. Applications for rechecking/obtaining photocopy, received after the prescribed time limit and not in the prescribed form will not be entertained.
