The candidates can avail only one chance. Applications submitted in any other manner will not be considered." - Since a common Written Test/ OMR test with common candidates was conducted for this Note (3) :post, the marks awarded to the candidates included in this Ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the common test.
- The result of rechecking of OMR answer scripts will be intimated in due course. But photo Note (4) :copy of the OMR answer scripts will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.
