A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

NOTE II:

A period of 45 days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date of approval of Ranked List. The candidates can avail only one chance after the approval of Ranked List.

Candidates desiring to get their answer script rechecked to the written test held for selection to the post may apply for rechecking within 45 days from the date of approval of the Ranked List(on or before **08.11.2017**).

After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised".
