The copy of an answersheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. Applications received after the prescribed date will not be entertained.
- Note (2) :- A period of 45 days time to apply for rechecking of answerscripts will be allowed to candidates with effect from the date on which this ranked list is brought into force. The candidates can avail only one chance. "Applications for rechecking of answerscripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or it's photocopy, or downloaded and printed in A4 size paper from the Commission's Website <a href="www.keralapsc.gov.in">www.keralapsc.gov.in</a> or photocopied there from. Applications submitted in any other manner will not be considered." After the publication of ranked list, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised".
