#### **NOTE I:**

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit the fee of Rs.300/- in any of the Treasuries in the State (Head of account: 0051 PSC-800-State PSC-99 other receipts).
