Candidates are prohibited from applying for printout of the answer sheet which is not their own, and legal proceedings will be initiated against those who do so.
- Note (2): Since a common Online Examination with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and mark of Online examination relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the common test.
- Note (3): Printout of Answer sheets will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.
