- Note (1) : Candidates who wish to obtain a printout of their answer sheet relating to this selection shall remit the fees of Rs. 300/- in any of the Treasuries in the State (head of account: 0051 PSC-800-State PSC-99-other receipts). The duly filled in application in the prescribed form (available from the Commission's website www.keralapsc.gov.in) along with the original chalan should be submitted to the Joint Secretary (Online Examinations), Kerala Public Service Commission, Pattom, Thiruvananthapuram - 4 within 45 days from the date of approval of this ranked list (on or before 07.08.2017 ). The printout of the answer sheet will be issued only once to a candidate. Printout of answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for printout of the answer sheet which is not their own, and legal proceedings will be initiated against those who do so.
- Note (2) : Since a common Online Examination with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and mark of Online examination relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the common test.
- Note (3) : Printout of Answer sheets will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test..
- Note (4) : Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal. The request for relinquishment received within 15 days from the date of publication of ranked list will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked list. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/ she is to be advised.
