- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List, to be published for the post.
- (6) Place, Date and Time of Dictation Test will be intimated in due course.
- (7) Copy of answer scripts of the OMR Test held on 03.09.2015 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No. ER IV B(1)3881/17/EW.
