NOTE (3):- Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A \& Part B) relating to this selection shall remit a Fee of Rs. 300/- (Rupees Three Hundred only) in any of the Treasuries in the State (Head of Account : 0051-PSC - 800-State PSC -99-Other Receipts). The duly filled in application in the prescribed form available from the Commission's website www.keralapsc.gov.in along with the original challan should be submitted to the Deputy Scretary (Examinations)-II, Kerala Public Service Commission, Pattom P.O., Thiruvananthapuram. - 4 within 45 (Forty Five) days from the date of approval of the Ranked List (on or before 25.05.2017)

A copy of an answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.
