Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is 12/10/2017. Applications received after the prescribed date will not be entertained.
- Note (2) :- A period of 45 days time to apply for rechecking of answerscripts will be allowed to candidates with effect from the date on which this ranked list is brought into force. The candidates can avail only one chance. - Note (3) :- Since a common Written Test/ OMR test with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the common test.
- Note (4) :- The result of rechecking of OMR answer scripts will be intimated in due course. But photocopy of the OMR answer sripts will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.
