Applications submitted in any other manner will not be considered." The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of ranked list. After the publication of ranked list, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised".
