NOTIFICATION

The following list contains the names of candidates found suitable on the basis of the result of the Objective Type Test (OMR Valuation) held on 13/03/2015 and the verification of original documents of candidates included in the probability List published on **04/03/2016** for selection to the post of **Lower Division Clerk/Bill Collector (Direct Recruitment from Low Paid Employees in the Kerala Municipal Common Service only)** in **Thrissur District** on **₹9940-16580** in **Kerala Municipal Common Service** (Category No. 347/2014), in Thrissur District arranged in the order of merit. The Ranked list is published on the basis of the Gazette Notification for the post dated 12/08/2014. The Ranked List is brought in to force **w.e.f. 12/04/2016**. The candidates included in the list shall be advised against the 5% vacancies from the Municipal Common Service reserved for them purely on the basis of merit. In case the candidates included in the Ranked List could't secure appointment before the expiry of the Ranked List, the names of such candidates will be included at the top of the new Ranked List of the Low Paid Employees drawn up by the Commission subsequently in the same order and they will be advised for appointment accordingly (Vide G.O. (P) No. 39/89/P&ARD dated 08/12/1989).

According to the existing procedure, revaluation of answer script is not allowed. But rechecking of marks will be done on payment of **₹75/- (Rupees Seventy Five only)**. The fees should be remitted in any one of the Treasuries in the State by chalan under the Head of Account "**0051 PSC 105 STATE PSC- 99 EXAMINATION FEE**". And original chalan enclosed with the application. The fee once remitted will not be refunded on any account. The result of the rechecking will be intimated to the candidates from this office. Application for re-checking of answer scripts should be

submitted in the prescribed format available free of cost from the Enquiry Section of the various offices of the Kerala Public Service Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website: www.keralapsc.gov.in or photocopied there from. Applications submitted in any other manner will not be considered. The original chalan receipt together with the application for rechecking should reach the District Officer, KPSC District Office, Thrissur within 45 days from the date on which this Ranked List is brought into force.

Candidates who wish to obtain a Photocopy of their OMR answer sheet (Part A and Part B) relating to this selection shall remit the fees of **₹300/- (Rupees Three Hundred only)** in any one of the Treasuries in the State by chalan under the Head of Account "**0051-PSC-800 OTHER RECEIPTS-99 OTHER RECEIPTS**". The duly filled up application in the prescribed form (available from the commission's website) along with the original chalan should reach the District Officer, KPSC District Office, Thrissur within 45 days from the date on which this Ranked List is brought into force. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own and legal proceedings will be initiated against those who do so.

Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, Name, Designation and Office Seal. The request for relinquishment received within 15 days from the date of publication of the Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

Valid applications for re-checking/obtaining photocopy of answer script addressed to the District Officer, Kerala Public Service Commission District Office, Thrissur shall reach this office within 45 days from the date on which the Ranked List has come into force (ie. the date on which the Ranked List has been approved by the commission).The last date for receipt of applications for rechecking/obtaining photocopy of the answer script is **27/05/2016**. Applications for rechecking/obtaining photocopy, received after the prescribed time limit and not in the prescribed form will not be entertained.

Letter 'R' should be prefixed to the Register Number to denote Thrissur District.
