The following list contains the name of candidates found suitable on the basis of the result of OMR Test held on 30.04.2016 and the verification of original documents of the candidates included in the Probability List published on 28.07.2016 for selection to the post of **CLERK TYPIST/TYPIST CLERK (By Transfer) on Rs.9940-16580/-** in Various Departments in **Ernakulam District (Category No. 046/2015)**, arranged in the order of merit. The Ranked List is brought into force with effect from **31.08.2016**. The candidates included in the list shall be advised against the 10% vacancies from low paid employees in the Kerala state subordinate service (including Last Grade Servants) for them purely on the basis of merit. In case the candidates included in the Ranked List couldn't secure appointment before expiry of the Ranked List, the names of such candidates will be included at the top of the new Ranked List of the low paid Employees drawn up by the commission subsequently in the same order and they will be advised for appointment accordingly vide G O(P) no.39/89/P&ARD dated 8/12/89.

According to the existing procedure, revaluation of answer script is not allowed. But answer scripts will be rechecked, to see that all the answers are valued and that there is no mistake in the totaling of marks for various answers if the candidates apply for rechecking, remitting the prescribed fee of Rs. **75/- (Rupees seventy Five only)** in any one of the Treasuries in the State by chalan under the Head of Account "**0051 PSC 105 State PSC 99 Examination Fee**". The fee once remitted will not be refunded on any account. The result of rechecking will be intimated to the candidates from this office. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Kerala Public Service Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's Website www.keralapsc.gov.in or photocopied therefrom. Applications submitted in any other manner will not be considered. Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A&B) relating to this selection shall remit the fees of **300/- (Rupees Three hundred only)** in any one of the Treasuries in the State by chalan under the Head of Account **0051-PSC-800-State PSC-99** Other receipts.

A copy of the answer sheet will be issued only once to a candidate.

Copies of OMR sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Valid applications for rechecking/obtaining photocopy of answer script along with the original chalan receipt should reach the District Officer, Kerala Public Service Commission District Office Ernakulam within 45 days from the date on which the Ranked List has come into force (i.e. the date on which the Ranked List has been approved by the Commission.) The last date for receipt of applications for rechecking/obtaining photocopy of the answer script is 14.10.2016 Application for rechecking/obtaining photocopy, received after the prescribed time limit and not in the prescribed form will not be entertained.

Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.
